I. Goals and objectives of joint training between the technical school and college

II. The main goals of the technical school and college:

- training of personnel on a paid basis, full-time study for a period of 3 years, based on the complexity of professions and specialties, in group x, formed in cooperation with foreign countries on the principle of "Lifelong learning", from persons with general secondary education who have completed educational programs corresponding to level 3 or 4 of the International Classification.

- training of personnel with professional qualifications on the basis of personnel instructions;

- training of personnel at the stage of secondary specialized vocational education, integrated with the higher education system, on the basis of educational programs corresponding to the 5th level of the International College of Education and Science,

- training students to become intellectually mature personnel who meet modern requirements in their chosen specialty, have in-depth knowledge, practical skills and qualifications, and high moral and ethical qualities;

- organizing events to increase the mobility of students and teachers.

III. Main responsibilities of technical schools and colleges

1. As part of this co-educational program:

- organization of qualified internships for students with the aim of exchanging experience;

- training of specialists with the skills of systematic thinking, office work, use of modern information and communication technologies and knowledge of foreign languages;

- from the 2023-2024 academic year, establishing cooperation between natural science teachers to improve pedagogical and professional skills;

- organization of scientific and practical conferences together with teachers;

- organization of professional competitions among students;

- development and publication of scientific articles, manuals, recommendations in cooperation;

- organization of classes within the framework of educational standards, ensuring a high level of educational knowledge in the disciplines of specialties and professional training within the framework of joint training,

- increasing professional competence, skills and qualifications of students in the process of obtaining qualifications in their chosen specialty within the framework of joint education;

- improving the system and content of training for these specialists within the framework of joint education, taking into account the needs of society, scientific achievements and modern innovative techniques;
- developing in students a sense of respect and pride for the national, cultural, historical traditions of the people of the partner state;
- formation in the minds of students of qualifications and skills that students must acquire in accordance with the requirements of educational standards for joint learning;
- protecting the health of teachers and students, introducing a healthy lifestyle, creating sufficient conditions for their education, living and recreation;
- creation of the necessary material, technical, educational and methodological base for the educational process of joint learning and the involvement of specialist practitioners with extensive experience in the educational process .

Organizing joint classes on the basis of a joint educational program.

Technical school and college teachers are involved in mutual training. In this case, teachers of the specialty will carry out certain modules specified in the curriculum.

Students' level of knowledge, skills and abilities on the topics covered is studied.

Payment for teachers' hours worked and student training will be discussed in an additional agreement.

Various forms of material and moral encouragement are applied to students who have achieved success in their studies, educational and production, creative and other activities of technical schools and colleges..

#### IV. Rights of teachers and students:

- directly or indirectly participate (through local governments and public organizations) in discussing and resolving issues related to technical activities;
- appealing administrative orders in accordance with the established procedure;
- refer to the guidance on completing the tasks set on the basis of the joint educational program;
- in accordance with the established procedure, free use of information libraries, services of educational, social, medical and other institutions;
- participation in the prescribed manner in various examination competitions aimed at developing professional competencies;
- applying for a job at a workplace recommended by employers;
- continuing education in relevant areas of higher education;
- in case of joint education, a specialist of secondary specialized education has the right to exercise the rights established by the educational program and other regulatory legal acts.

Students may also have other rights under the law.

#### V. Responsibilities of teachers and students:

The requirements established by the educational standard must be fulfilled by students within the specified period of time, as well as

- acquire knowledge, skills and abilities;
- do not miss classes without reason;

- compliance with this program, internal procedures, etiquette and academic discipline; - maintain the safety of the premises of the educational institution and its property;
- timely fulfill your obligations under the payment agreement.

Academic leave can be granted in accordance with the law if there is a group of specialists in the same specialty in the upcoming academic year.

#### VI. Organization of the educational process.

The parties agree that the beginning and end of the academic year, the weekly workload, the duration of the holidays, as well as the forms for determining the completion of the educational process, the rules of practice and the procedure for conducting the final state certification, as well as other requirements related to the educational process, are agreed on the basis of the approved curricula. other regulatory documents

Training plans for each area (profession) are developed and approved by agreement of the parties. All types of training are conducted according to a critical-modular system by agreement of the parties. The duration of the module is determined by the relevant regulatory documents;

Students are trained under a joint educational program based on the interaction of education with science and production.

- With the aim of training personnel capable of directly participating in the processes of modernization of production, innovative ideas for the educational process are being introduced using technologies and developments that ensure close cooperation between technical, university and medical institutions and organizations.

#### VII. Main objectives of joint educational programs

The main objectives of joint educational programs are:

- ensure the organization of the educational process of the joint educational program on the basis of regulatory documents;
- provision of educational services that meet consumer requirements within the framework of a joint educational program and ensuring the quality of education that meets international educational standards;
- improvement of normative and methodological support for organizing the educational process in a joint educational program;
- send students to study at a foreign educational institution partner in accordance with the curriculum, coordinate issues of attracting foreign professors and teachers to the educational process and cooperate in this direction with the foreign partner;
- maintaining and developing cooperative relationships with other structures of the educational institution;
- of advanced educational programs and technologies into the educational process , studying the requirements of science, education and market relations.

The form of the educational process is organized on the basis of the selection of scientifically based innovative teaching tools and methods.

Scientists and specialists are involved in the educational process. The technical school creates conditions and encourages the educational, methodological and scientific quality of teachers.

### VIII. Teachers and their activities.

Classes can be conducted in online and offline formats (as agreed by the parties). Based on the joint educational program, the technical school/college draws up work programs for subjects (modules) of the curriculum and approves them in the relevant ministries

The number of credit modules and training hours is determined for each specialties separately.

### IX. Approval of educational programs and curriculum

The educational program and training plans are reviewed and approved by the parties' organizations. Certified copies are sent to the partner institution. The approved curriculum and extracurricular program will be implemented. Teaching is conducted in English. To do this, teachers of special subjects must speak English. To better solve the language issue, natural science teachers are required to take a short course in studying the English language. Teachers appointed to teach subjects (modules) of the Approved Curriculum develop educational regulations for the subject taught.

The educational regulations are prepared in English.

### X. Audiences and material and technical bases

In order to implement cooperation, special training (by specialty) will be introduced. Innovation and simulation rooms adapted to co-educational program.
